Services to Arts + Creative Individuals and Businesses - The Arts Alliance provides services responds and assists the artists, creatives, cultural specialists, creative organizations and businesses guidance, resources, services, relief, connections and more. It promotes the arts and creative industries' programs including: a biweekly online eNewsletter, publishes the Arts + Creative Industries Guide and co-produces a weekly radio show, creative:impact, on WEMU 89.1 FM. It celebrates The Arts Alliance Medal for Arts, Sciences & Humanities, awarded annually to honor and celebrate the extraordinary contributions and accomplishments of Washtenaw County artists, creatives, individuals, businesses and organizations.

Region 9 Regranting: The Arts Alliance is an administrator for the Michigan Council for Arts and Cultural Affairs regranting program. It serves Region 9: Hillsdale, Jackson, Lenawee, Livingston, Monroe and Washtenaw counties. The Arts Alliance offers training sessions, sample narratives, budgets and an online application system tutorial. The same is provided for the peer review panels before they are convened to evaluate, score and distribute minigrants.

Facilitating Projects and Assessments: The Arts Alliance is engaged in conducting research, needs assessments and project management including these: 1) Arts & Cultural Education Integration for Student Excellence (ACEISE) a project in partnership with the Washtenaw Intermediate School District (WISD) to ensure that the 47,000 students attending school in Washtenaw County have equitable access to high quality, consistent, sequential and standards-based education through the arts, culture, design and creativity. 2) PowerArt! is a multiyear project to wrap 42 traffic signal boxes in downtown Ann Arbor with vinyl-printed replicas of local artists' work. In total Washtenaw County-based artists will be paid \$60,900 for this project.

The Arts Alliance is an independent regional agency, its mission is to support and advocate for the arts + creative industries in Washtenaw, MI and ensure that the greater area remains a great place to create, live, work, learn, play and visit. It serves creative professionals, amateurs, students and industry experts leading the sector locally, nationally and internationally who have creative practices, own creative businesses and hold creative jobs in profit, nonprofit, educational and government entities and produce creative goods, services and programs for county residents and visitors.

Still, the board of directors is aware of the top official’s compensation and takes it into consideration when reviewing its management agreement with Artrain, Inc.
